2017-2018 TCAP Schedule

As required by Public Chapter 892, this is a listing of state mandated assessments for the 2017-2018 school year.

In the 2017-2018 school year, TNReady refers to the TCAP test for English language arts, math, science and social studies in both Grades 3-8 and High School End-of-Course (EOC). All state assessments fall under the Tennessee Comprehensive Assessment Program (TCAP) umbrella. During the upcoming year, districts will have the opportunity to select the process of paper and pencil or online assessments. Parts of the TCAP may be both online and paper and pencil (e.g., Science paper and pencil, TNReady either).

Grades 3-8 TCAP TNReady Assessment

The following TNReady and Achievement tests will be given in one part this year, at the end of each semester for semester classes at the HS and the spring for grades 3-8. Each content area will consist of multiple choice and selected response items. ELA and Social Studies will one written response

- In reading and writing – students will read from texts and provide written responses to support their answers.
- In social studies – students will respond to extended response items

TCAP Achievement Science will measure current content standards using only multiple-choice questions.

During this school year, the assessment will be paper-and-pencil for grades 3-8. District who qualify may opt to have grades 9-12 take their assessment online.

Purpose & Use

Administration Window

April 16 – May 4, 2018

The first week of the window will be Subpart 1, which eludes to the writing portion of the assessment in ELA & Social Studies. The remaining contents and subparts will be administered within a 10-day period. This allows schools to adjust the amount of testing during one day.

Grades 9-12 TCAP TNReady EOC Assessments

The following TNReady EOC will be administered to any student enrolled in the following classes:

English/Language Arts: English I, English II, English III

Math: Integrated Math I, Integrated Math II, Integrated Math III

Science: Biology and Chemistry

Social Studies: US History

Each content area will consist of multiple choice and selected response items. ELA and Social Studies will one written response

- In reading and writing – students will read from texts and provide written responses to support their answers.
- In social studies – students will respond to extended response items

TCAP Achievement Science will measure current content standards using only multiple-choice questions. The District who qualify may opt to have grades 9-12 take their assessment online with Science being paper and pencil.

Purpose & Use

The new TNReady TCAP tests are designed to assess true student understanding and not just basic memorization and test-taking skills. TCAP EOC Biology, Chemistry and U.S. History are given to help measure how much a student grows academically over the course of a school year.

Administration Window

Year long classes: Spring April 16 – May 4, 2018

Semester Classes: Fall – Nov. 27-Dec. 15, 2017

Spring – Apr. 16 – May 4, 2018

Districts may select a five-day testing window within the state's administration window. The state will give exact dates later this fall.

Length of Assessment

Each test Part (by subject) is divided into two subtests. All test times will be finalized in early to mid Fall.

- English I, II, and III: 45-50 per subtest (3) and 85 minutes Writing Subtest (1)
- Integrated Math I, II, and III: 35-55 minutes per subtest (3)
- Biology and Chemistry: 75 minutes for the assessment (1 subtest each)
- US History: 45 minutes per subtest (2) and 50 minute Writing subtest (1)

English Learner Assessment**[ACCESS for English Learners/\(WIDA\)](#)**

English Learners will take the ACCESS for ELLs to determine language proficiency. ACCESS assesses students in the four language domains of Listening, Speaking, Reading, and Writing.

Purpose & Use

Administered to English Learners to evaluate English proficiency.

Administration Window

March to mid-April 2018

Length of Assessment

The test is self-paced with target administration times for each section of the test as follows:

- Listening: Up to 40 minutes
- Reading: Up to 35 minutes
- Speaking: Up to 30 minutes
- Writing Tier A: Up to 45 minutes
- Writing Tiers B/C: Up to 60 minutes

Special Education Assessment

MSAA & TCAP-Alt

The MSAA Assessment will be administered throughout the year collecting student work in Reading/Language Arts and Math, as well as the TCAP-Alt portfolio assessment in Science and Social Studies. TCAP-Alt is an alternate assessment based on alternate achievement standards. This assessment is appropriate for students with a significant cognitive disability as determined by the Individual Education Plan (IEP) team. All of these assessments will be administered online.

Applicable Federal/State Law

The development of alternate achievement standards for students with the most significant cognitive disabilities and their use for making adequate yearly progress (AYP) decisions is authorized under a Department regulation (34 C.F.R. Part 200) published on December 9, 2003. The Individuals with Disabilities Education Act (IDEA), section 504 of the Rehabilitation Act of 1973, and title I require inclusion of all students with disabilities in the State assessment system.

Purpose & Use

This test is given to help measure how much a student grows academically over the course of a school year.

Administration Window

Reading/Language Arts and Math will be administered in spring 2017 over a two month window. Exact dates to be determined but we anticipate March – April as the testing months.

Science and Social Studies may begin to collect data on the first day of school. Data collection may go through the end of January and data must be entered into the online platform by the end of February 2017.

Length of Assessment

- NCSC English/Language Arts: Administered over a two month testing window
- NCSC Math: Administered over a two month testing window
- Alt Science: Data collection may begin on the first day of school through the end of January 2017
- Alt Social Studies: Data collection may begin on the first day of school through the end of January 2017

Additional Assessments for Specific Grades

ACT (Grade 11)

Required: Yes

Applicable Federal/State Law

Administered in accordance with T.C.A §49-6-6001(b).

Purpose & Use

These exams are used to measure college readiness and HOPE scholarship eligibility.

All Tennessee students receive one free voucher for either ACT or SAT; requests for vouchers should be at the student's school.

Administration Window

State & PCSS window: March 20, 2018; April 3, 2018, and April 24, 2018

Accommodation window: March 20-April 3, 2018

Students may also take the ACT Weekday Test. These test dates are listed at [ACT Registration | Test Dates in the U.S., U.S. Territories, and Canada.](#)

Students may also take the SAT on the dates listed at [US SAT Registration.](#)

Participation in the statewide administration counts as using a voucher.

Length of Assessment

ACT:

- English: 45 minutes
- Math: 60 minutes
- Reading: 35 minutes
- Science: 35 minutes
- Writing: 30 minutes

SAT:

- 25-minute essay
- Six 25-minute sections (mathematics, critical reading and writing)
- Two 20-minute sections (mathematics, critical reading and writing)
- 10-minute multiple choice writing section

Results to Parents & Students

For ACT, student level reports are provided to student approximately three to eight weeks after the administration of the assessment by ACT.

Administered in accordance with the No Child Left Behind Act of 2001 §1111 (c)(2) which requires the state to participate in the biennial state academic assessments of fourth grade reading and mathematics.

Purpose & Use

Only a small sample of Tennessee fourth and eighth graders will take this test. This test, often called the nation's report card, measures Tennessee's academic achievement against other states also taking this test.

Administration Window

End of January through March 2017

Schools and students are randomly selected to participate in the nation-wide assessment. Schools and dates will be released upon the notification by TDOE.

Length of Assessment

60 minutes

International Assessments

PISA

The Program for International Student Assessment is an international assessment that measures 15-year-old students' reading, mathematics and science literacy. The assessment is given every three years. [More information is available here.](#)
